2285. APOLOGIES FOR ABSENCE

Apologies were received from Cllr. J. Akin and the reason accepted.

2286. DECLARATION OF INTERESTS

Councillors were asked to state their pecuniary and non pecuniary interests in matters to be discussed at this meeting.

2287. MINUTES OF THE LAST MEETING

Resolved: The minutes of the Council meetings held on 7th January, 2014, having been circulated to members were agreed and signed by the Chairman as a true record.

2288. PUBLIC PARTICIPATION

Standing Orders were suspended to allow residents to speak.

Affordable Housing in Catterall

A resident asked about the support the affordable housing got from the Parish Council and it was explained that although the land in question was outside the settlement boundary it is deemed an exception site and suitable only for affordable housing. There were no planning reasons to object to the site, which will accommodate the 16 houses. She stated that at the planning committee at Wyre an officer stated that the rest of the land has been released for housing. The Councillors were unaware of this reported statement, but will raise it with the Wyre Councillor when he arrives.

Reply from Wyre Council 'Baylton Drive – this area is not allocated as housing in the adopted Local Plan. If an application was to come in for housing in the future for the land surrounding where the application on last committee was approved it will be considered in light of planning policies that are relevant at the time of the application.'

Report from County Cllr. S. Perkins

It has been confirmed that Garstang Household Waste Recycling Centre will re-open later this year or early next year. Councillors were pleased to hear that this valuable facility will again serve the area and thanks should go to the Councillor.

Reporting vehicles parked on the pavement

Last month P C Jones told Councillors to ring 101 to report obstructing vehicles, but when this was carried out the Police were not that interested. However, Sgt Freaney supports P C Jones information and if a vehicle is causing an obstruction of the highway/pavement and the person who is obstructed wants to make a complaint, it has to be phoned through to 101 for an on duty traffic officer or any other available officer (including the CBMs) to deal with the offending vehicle.

The meeting was resumed.

2289. ROADSIDE FENCE TO THE QUEEN ELIZABETH II PLAYING FIELD

Councillors considered the state of the low fence, put in to mark the extent of the Parish Council's land at the time of Taylor Woodrow's planning application for Nightingale Way, as it is starting to rot. Councillors felt it should be maintained to stop vehicles running onto the grass verge.

Resolved: To cost the maintenance work needed to retain the roadside fence at the Village Hall.

2290. PLAY PROVISION FOR QUEEN ELIZABETH II PLAYING FIELD, CATTERALL

Councillors had met with Mark Billington, Wyre Council, to discuss various play provisions for the playing field and followed this with a visit to Wrea Green to view Street Snooker as an example of what could be used and accepted by Wyre. Wyre Council is to send recognition that the money is available for Catterall Parish Council to use and this will be used to access grant funding to purchase equipment. Councillors considered the Street Snooker as phase one to the play facilities and others can be added later.

Resolved: That Street Snooker is accepted in principle for phase one of the play facilities and a suitable location will be sought.

2291. RWE – CUCKOO WOOD WIND FARM

RWE invite Catterall Parish Council to meet them to discuss Cuckoo Wood Wind Farm.

Resolved: Whilst the Councillors were reticent at the meeting they will support Kirkland Parish Council when they attend.

Standing Orders were suspended to allow residents to speak.

Wyre Councillor D. Swift

Cllr. Swift reported that Wyre Council came fifth in the Loo of the Year and that they have created more jobs than any other council. Wyre Council opposes the proposed Halite development and opposes the Police Commissioner's increase in the council tax as there was over £5million left in their budget for this year.

He was told of the planning officer's statement concerning the affordable housing and asked to make enquiries.

The meeting was resumed.

2296. REPORTS FOR INFORMATION ONLY**Wyre Area Lancashire Association of Local Councils**

Meeting held on Tuesday 21st January, 2014

Lancashire County Council: The Government has lowered the grant to County by 10% and that the budget is to be lowered and this will result in substantial cuts to services. There is a move to change the highway reporting line to a 0300 number and potholes can be reported on the website.

Wyre Council: Although the Government is sure that district councils will passport on the Localised Council Tax Grant to Parish Councils, Wyre will not be doing this. It is rolled up in so many other cuts that it is impossible to segregate out. The calculations for the tax base were explained to arrive at a Band D property.

Police: Reported that there is to be no change in the number of Police officers in Garstang and Garstang Police Station will remain. The annual crime figures were presented.
